Terms and Conditions

1. The Establishment Guarantee™ program applies to the establishment of Seed Distributor products within the first 30 days after planting, in cases where best management practices have been used. The program does not cover crop failure after this time.
2. Growers must register to be eligible for the Establishment Guarantee™ program. Registration can be obtained by filling out the bag tag and sending it to Seed Distributors or by registering on-line at www.seeddistributors.com.au. Seed Distributors reserve the right not to provide replant seed in cases where registration has not occurred.
3. Claims for Establishment Guarantee™ can be submitted to Seed Distributors through the outlet from which the seed was purchased. A Seed Distributors representative or an agent appointed by Seed Distributors must verify the claim before approval is provided. A proof of purchase must also be provided.
4. Claims must be submitted to Seed Distributors before the paddock is sprayed, grazed or ploughed for Replant.
5. In the event of a claim being approved, Seed Distributors shall provide replant product to the dealer the product was purchased from. Growers can then purchase the product at 50% off the original purchase price.
6. Replant seed will be provided for the same crop year that the original seed is purchased and planted.
7. The replant credit will apply to the retail price of the replant Product, but does not apply to the cost of any additional (non-standard) seed treatments in the original purchase product or on the Replant product.
8. In the event the product has been used as part of a seed mix, the Establishment Guarantee™ will apply only to the portion of the mix made up of Seed Distributor products.
9. In the case of a successful claim Seed Distributors will endeavour to provide seed of the same or similar variety (subject to availability). If there is a 'sold-out' situation seed will be provided the following season.
10. If the purchaser decides not to Replant, or after the Replant product is provided to the purchaser, all obligations under the Establishment Guarantee™ have been met.
11. The decision of Seed Distributors, or any of their representatives or agents, shall be final and no correspondence shall be entered into.
